In consideration of the acceptance of this entry by AAC and Sundog Agility (the “Organizing Club”) and the opportunity to have the Dog participate, compete in and/or be judged at this event or trial (the “Event”), I, the undersigned, agree as follows:

1. I certify that I am the actual owner of the Dog, or that I am the duly authorized agent of the actual owner of the Dog and that the Dog is not a hazard to persons, property or other dogs.
2. I agree that AAC or the Organizing Club for the Event may refuse my entry for any reason that it deems to be sufficient.
3. I understand and acknowledge that participation in the Event carries certain risks, including, but not limited to injuries (including serious injuries and death) to myself, the Dog, another dog under my control or persons attending as my guests (my “**Related Parties**”), damage to property and other losses. I waive any and all claims that I have or may have in the future against, and release from all liability and agree not to sue AAC, the Organizing Club or any of the directors, executives, committees, representatives, employees, volunteers or agents of either AAC or the Organizing Club (the “**Personnel**”) for any injury, death, property damage or other loss that I or my Related Parties sustain due to any cause whatsoever, including negligence, breach of contract, breach of duty, statutory or otherwise, or mistakes or errors of judgment of any kind.
4. I assume full responsibility for the conduct of myself and my Related Parties during the entirety of the Event. I agree to indemnify and save harmless AAC, the Organizing Club and the Personnel from and against any and all claims that may be made against them or costs, fees, expenses or liability (including, without limitation, lawyers’ fees on a solicitor and own client basis) incurred by AAC, the Organizing Club or the Personnel that may arise due to:
  - (a) any act or omission of myself, my Related Parties or any party for whom I am liable at law; or
  - (b) aggressive behaviour by the Dog or any other dog under my control.
5. I have read, and do understand the rules of competition and the additional rules (if any) appearing in the trial schedule for the Event, as well as the policies of AAC pertaining to discipline (collectively, the “**Rules**”). I agree to abide by the Rules and to conduct myself and the Dog in accordance with the Rules. I understand that myself and/or the Dog may be subject to disciplinary procedures or sanctions for breach of the Rules and agree to respect and be bound by any disciplinary decision made by AAC.
6. I understand that AAC and/or the Organizing Club may, in the course of administering the Event or conducting its activities generally, collect, use or disclose my personal information and that any personal information collected, used or disclosed by AAC and/or the Organizing Club will be treated in accordance with AAC policy and applicable privacy and personal information laws. I hereby consent to the collection, use and disclosure by AAC and/or the Organizing Club of my personal information.

**Media Release & Rights of Privacy Waiver**

I Hereby Grant to AAC and its affiliated companies, representatives, agents and assigns, all rights and permission to use or appropriate his/her and their dog’s name, biography, likeness, photograph, voice, performing persona, or other indicia of identity for broadcast, telecast, cablecast, transmission or distribution in any format or media known now or in the future.

**Waiver of Rights to Privacy, Publicity & Personality**

Further, I hereby release Agility Association of Canada Inc, and its affiliates, representatives, agents and assigns from any claim or cause of action for invasion of the rights of privacy, right of publicity, right of personality, or any similar rights.

The Alberta Freedom of Information and Protection of Privacy Act; enacted January 1st, 2004; requires that consent be obtained for the collection and use of personal information. The information collected by the Sundog Agility will be used for:

- Registering and listing competitors in agility events
- Submitting results, as required by the sanctioning body
- Contacting competitors by email or mail for future agility events, such as trials and seminars.

All information collected from or pertaining to all competitors will be kept private and confidential unless authorized in writing by the competitor. All paper copies of entries containing personal information will be destroyed after a period of six months.

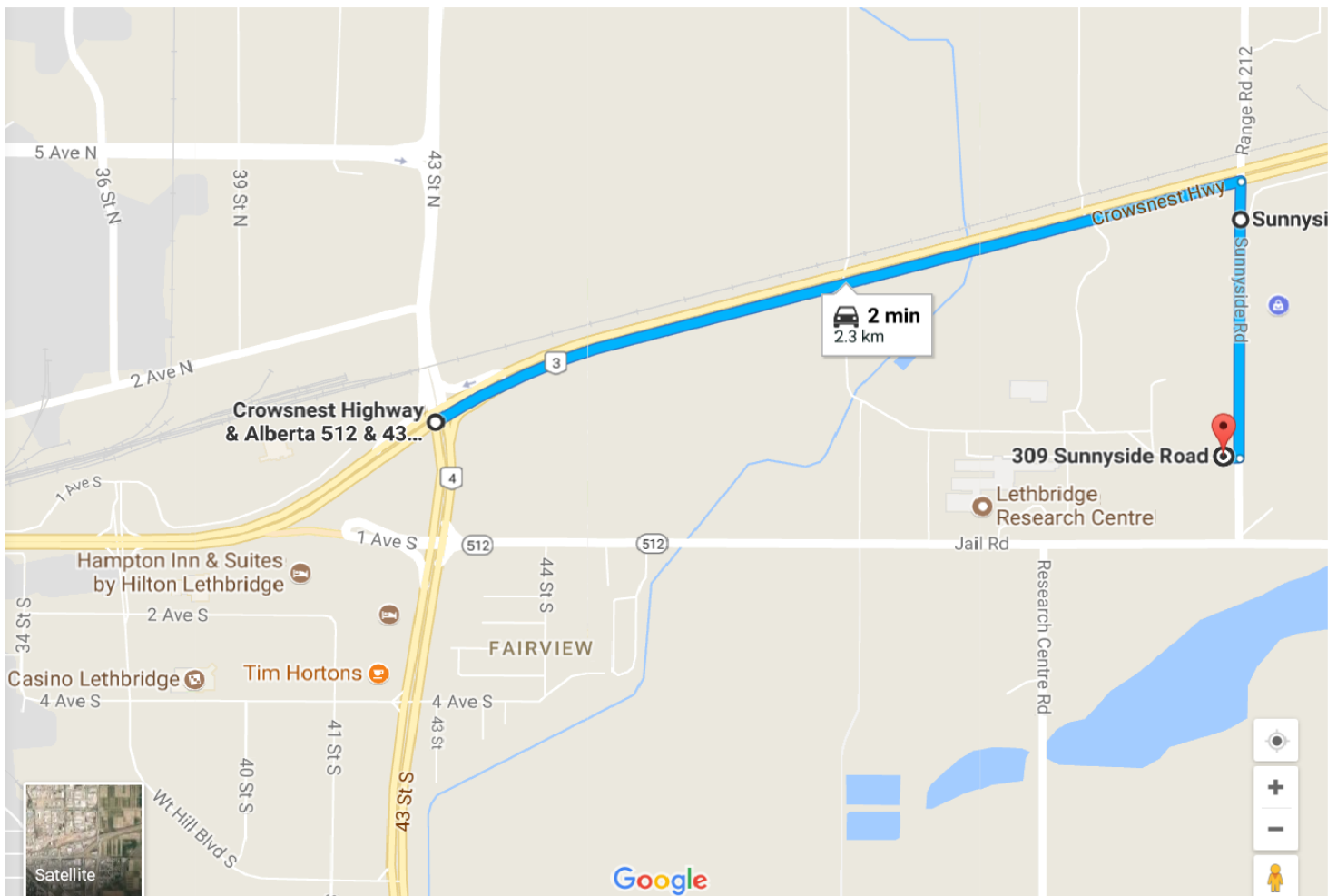
### **Notice to Exhibitors**

- Exhibitors, through submission of entry, acknowledge they are knowledgeable of the rules and regulations of the AAC, including but not limited to the following:
- This event is held under AAC Rules and Regulations and is open to all dogs being at least 18 months of age, pure bred or mixed breed, except bitches in season, aggressive dogs, or dogs suffering from any deformity or illness which may affect the dog's physical or mental performance (Judges discretion).
- **As of January 1, 2001, all dogs must have an AAC number before their entries will be accepted in an AAC sanctioned trial. Dogs with numbers pending will not be eligible to compete.**
- **As of January 1, 2016**, certain toys **MAY** be allowed on course for **FEO** runs at the discretion of the **HOST CLUB**. If allowed, please be considerate of the dogs before you & after you, as a toy may distract the dog on course and/or may over excite the dog following you in line.
- Obstacles shall be chosen from those described in the current edition of the Rules and Regulations of the AAC and shall conform to AAC specifications.
- No leads, collars, food, toys or any other aids or devices shall be permitted on the course at any time. The only exception to this rule is leading your dog on leash to the start line and taking your dog from the ring on leash when finished.
- Please take responsibility for your dogs and children. Any exhibitor whose dogs and/or children create unnecessary disturbances or engage in unsafe or disruptive behaviour may be asked to bench in your vehicle or leave the trial site. There will be no refunds for entries if an exhibitor is dismissed from competition for any reason.
- All dogs must be penned, crated or leashed when not in the ring. All dogs must be under control when exiting the ring. Any dog engaging in aggressive or out of control behaviour may, upon exit of the ring, be disqualified and/or required to leave the trial grounds and no refund of fees shall be given.

### **Entry Rules**

- Sundog Agility reserves the right to refuse any entry.
- Anyone not in good standing with AAC or Sundog Agility will not be allowed entry.
- Only mailed or Express Post entries will be accepted. No faxed, hand-delivered, Couriered, Emailed, or Group entries. Entries postmarked before the opening date, or after the closing date, may not be accepted. This will depend on whether manageable limits have been reached (approximately 375 runs/day).
- Entries must be postmarked **July 1<sup>st</sup> 2018** and up to and including **August 15<sup>th</sup> 2018**
- Cheques are to be made out to **Sundog Agility** and dated no later than the closing date.
- Refunds will not be given for cancellations after the closing date except for bitches in season or injury to a dog or handler that physically prevents them from competing. Veterinary letter may be required. Refunds for any other reason will be handled on a case to case basis and will be at the discretion of the Sundog Agility Trial Committee. Please note there will be a \$15.00 administration fee applied to any refund request received after the closing date.
- By AAC Rules, entries are **NOT** valid until payment of entry fees has been received or confirmed.
- **NOTE: Everyone must show their new 2018 height card before running at each trial in 2018 (new AAC rule). If you already have a completed card, you may send a copy of it with your entry to avoid needing to check in at Sundog trials (will be kept on file). Anyone needing measuring for 2018, must produce their new card when measuring is called.**

## DRIVING DIRECTIONS



### **From Calgary to Lethbridge** (approximately 2 hours)

- Highway 2 South to Lethbridge
- Turn east onto Highway 3
- Continue through city on Hwy 3
- At 43<sup>rd</sup> Street traffic lights continue east for 1.8 km
- Turn right (south) onto Sunnyside Road
- Go 1 km (south) and on right side is the trial site

### **From Medicine Hat to Lethbridge** (approximately 1 hour 45 minutes)

- Highway 3 West to Lethbridge
- Approximately 2 km before the first set of lights on 43<sup>rd</sup> Street turn left (south) onto Sunnyside Road
- Go 1 km (south) and on right side is the trial site

### **From Lethbridge Highway 3 & 43<sup>rd</sup> Street Intersection Lights**

- Turn South and go approximately 1/4 km
- Turn East onto Jail Road (512E)
- Go 1.7 km east
- Turn left (north) onto Sunnyside Road
- Go approximately 1/2 km and on left side is the trial site
